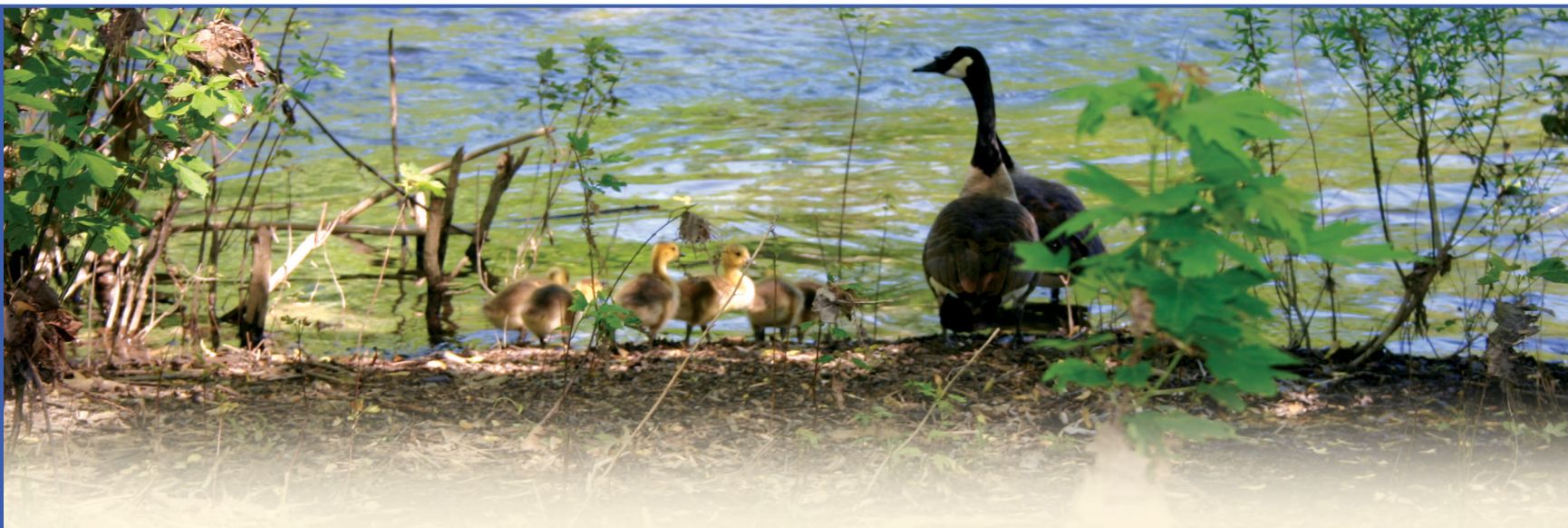

With an ever growing population, Silver Spring Township is one of the fastest growing townships in Pennsylvania. Silver Spring encompasses 33.6 square miles, with 93 miles of roads. The Township is bordered on the north by the North Mountains, on the east by Hampden Township, on the south by Monroe Township and Mechanicsburg Borough, and on the west by Middlesex Township. The Appalachian Trail runs along the western and northern Township boundaries. Silver Spring Township is traversed by three major bodies of water: the Conodoguinet Creek, Hogestown Run, and Trindle Spring Run, and includes the villages of Hogestown and New Kingstown.

The area was once home to heavily traveled Native American trails and shares the Revolutionary and Civil War heritage of the region. Its strategic location offers benefits that attract residential, industrial, and commercial development to the municipality. With close proximity to Interstate 81 and the PA Turnpike, the Township offers a natural starting point to major cities.

As a Second-Class township, Silver Spring is governed by a Board of Supervisors consisting of five elected officials, each serving a six-year term. The Board is charged with the general governance of the Township to secure the health, safety and welfare of the citizens of the community and adopts laws that govern various activities within the Township. The Board, in turn, is governed by both the Second Class Township Code and other laws of the Commonwealth. Municipal services include Administration, Police, Public Works, Community Development, Sanitary Sewer/On-Lot Septic, and Parks and Recreation.

Hidden Creek Park

50 Millfording Road, Mechanicsburg

14 Acres. Pavilion w/six (6-foot) picnic tables and single charcoal grill - playground w/swings - benches - creek access (parking lot closest to Sewer Plant) - four soccer fields - trail - portable restrooms.



Pleasant View Park

90 Pleasant View Drive, Mechanicsburg

12 Acres. Pavilion w/twelve (8-foot) picnic tables, electric and double charcoal grill - benches - playground w/swings - dual-lined tennis/pickleball courts - two basketball courts - sand volleyball court - soccer field - softball/baseball field - trail (one loop is .54 miles) - indoor restrooms.



Paul Walters Memorial Park

10 Elm Street, Mechanicsburg

44 Acres. Playground w/swings - benches and picnic tables near the playground - four softball/baseball fields - concession (rental only) - portable restrooms.



Potteiger Park

15 John King Lane, New Kingstown

7 Acres. Pavilion w/six (6-foot) picnic tables and single charcoal grill - playground w/swings - benches - T-ball field - trail (one loop is .37 miles) - portable restrooms.



Stony Ridge Park

50 Bernheisel Bridge Road, Carlisle

103 Acres. Wood pavilion w/eight (8-foot) picnic tables and single charcoal grill - building pavilion w/six (8-foot) picnic tables and electric - playground w/swings - benches - parking for Appalachian Trail (within 500 feet of park edge) - eight softball/baseball fields - four multi-purpose fields - two football fields - trail (one loop is roughly 1 mile) - concession (rental only) - indoor restrooms.



Vincent DiFilippo Nature Preserve

110 Sample Bridge Road, Mechanicsburg

54 Acres. Picnic tables and benches - trail (various loops ranging from 1 mile to 2 miles) - creek access (parking lot next to Sample Bridge) - wetlands and ponds - meadows - woody areas - educational signs - wildlife viewing areas - portable restrooms.



Willow Mill Park

80 Willow Mill Park Road, Mechanicsburg

18 Acres. Pavilion w/wood tables (seating 100+), electric and double charcoal grill - picnic tables and benches - single charcoal grill near garden area - playground for kids 5 and under - Veterans Memorial - disc golf course (9-hole beginner course with maps at each tee) - creek access (parking lot below Veterans Memorial) - Historic Huston Mill - wetlands - portable restrooms.



Dog-Friendly Parks

Dogs are permitted in the parks, but there are specific rules that the owners/handlers must follow: (1) Dogs must be on a leash, no more than six (6) feet long, (2) dog owners/handlers must clean-up after their dog and properly dispose of waste, (3) dogs must be physically controlled and attended at all times, (4) dogs are prohibited in playgrounds, athletic fields, inside buildings, and any

other area designated closed to dogs. Report violations by calling the Silver Spring Township Police non-emergency line at 717-238-9676. In an emergency, dial 911.

Alcohol and Tobacco-Free Parks and Playgrounds

Smoking or use of tobacco products, including vaping, is not permitted in the parks. Silver Spring Township is a partner of the Pennsylvania Department of Health "Young Lungs at Play" initiative, eliminating children's exposure to secondhand smoke at public parks and playgrounds. This initiative protects the environment and the health of all.

PUBLIC WORKS

The Public Works Department offers many services for our residents:

Road Improvements and Maintenance: The Township's 93 miles of dedicated roads and streets are maintained by The Public Works Department throughout the year. The Township announces scheduled road work on the website. Please drive slowly in work zone areas.

Parks Maintenance: The Public Works Department handles the mowing and upkeep of approximately 254 acres of Township owned land and the maintenance of all parks buildings, including all public use pavilions.

Street Sweeping: Silver Spring Township sweeps dedicated streets during a 3-4 week period in early fall. The Township requests that residents keep their vehicles, basketball hoops, trash cans, and other objects off the roads during sweeping.

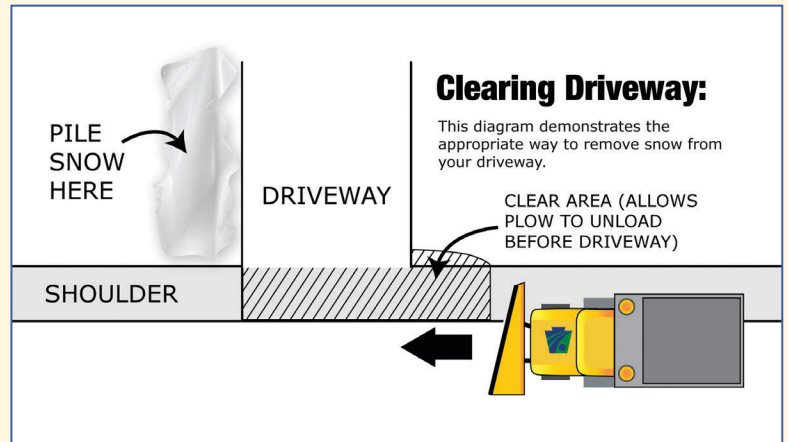
Yard Waste Disposal: Silver Spring Township partners with Mechanicsburg Borough to offer a drop off location for the disposal of leaves, brush and shrubbery clippings, which are then turned into mulch. Residents are permitted to pick up mulch for use on their personal property, at no charge. The Joint Compost Facility is located at 842 West Church Road in Mechanicsburg. Access cards are available for both residents and commercial businesses by contacting either municipality. Access cards are available at the Township office.



Leaf Collection: From mid-October through early December (weather dependent), the Township's Public Works Department utilizes a leaf vacuum to collect the fallen leaves throughout the Township. Residents

should rake their leaves within one foot of the curb. Yard waste, sticks, grass, bags, etc. left in the piles or mixed in with the leaves will not be picked up. The success of the leaf collection process is a combined effort between the Township and the residents.

Tree Trimming: Silver Spring regulates the size of trees, shrubbery and bushes in Township rights-of-way. This includes rules concerning the clearance of obstructions, trimming of trees and shrubs, and removal of trees or trimmed debris.



Snow Plowing: Silver Spring Township Public Works Department works diligently to clear ice and snow from dedicated Township roadways in a timely manner. Trucks have designated plow routes with each route starting with main roads, moving to secondary roads and then to development roads. It is the Township's policy to clear all roads from "curb to curb" whenever possible to provide safe traveling for motorists. Residents of the Township can assist in this effort by removing all vehicles from the roadways during snowstorms. Always clear an area to the right facing your driveway to give the snow on the blade of the plow a place to empty before it gets to your driveway. The Public Works Department also reminds you that it is illegal to push snow from a parking lot or driveway onto Township roadways.

The Silver Spring Police Department is an accredited law enforcement agency from the PA Law Enforcement Accreditation Commission through the Pennsylvania Chiefs of Police Association. The Department includes officers with specialized training in School Resource Officer (SRO), Motor Carrier Safety (MCSAP), Special Response Team (SRT), a K-9 unit and a Bicycle unit. The Police Department provides coverage to the area 24/7. Our police officers play a vital role in serving and protecting the community from monitoring criminal activity to participating in community events such as Shop with a Cop, National Night Out, Community Egg Hunt, and Trick or Treat Night under our Cops Care For Kids program.



Door to Door Solicitation

The Township allows for the offering of goods, wares, services, or merchandise by visitation to private residences. Door to door solicitation requires a permit, along with a background check, issued by the Police Department and includes a photo of the specific person who is authorized to conduct the solicitation. Do not respond to anyone who cannot produce a solicitation photo permit card and report them immediately to the Police Department by calling 717-697-0607 or 911.

Autism, Special Needs, Alzheimer's and Dementia Registries

We recognize the importance of time in tracking a wandering and vulnerable loved one. In an effort to efficiently serve and protect the citizens of Silver Spring Township, we offer a voluntary registry in which family members can register loved ones who are suffering from Autism, Special Needs, Alzheimer's or other forms of dementia. Having information readily available enables us to work with surrounding agencies in hopes to quickly locate and safely return your loved one. If you have any questions concerning these registries, please contact the Police Department at 717-697-0607 or see our web page at www.silverspringpolice.com. All registry information will be securely maintained at the Police Department and will be used solely to aid law enforcement and other emergency personnel in locating the missing person.

Voluntary Surveillance Camera Registration Database

Cameras help solve crime. We are asking residents and businesses to partner with us in the detection, prevention, and solving of crimes. Often a crime will occur that may have been caught on camera and may be useful in our criminal investigations as well as helping to keep our community safer. We suggest residents and business owners complete the surveillance camera registry form found at www.silverspringpolice.com. This is a voluntary registration and your personal details will be kept confidential.

Fingerprinting

Fingerprinting is available for Township residents and businesses at the Police Department from 8:00 am to 3:00 pm, Monday through Friday. A fee

of \$20.00 is assessed for each fingerprint card, check or credit card only. Please call 717-697-0607 to confirm availability.

Internet Purchase Exchange Location

An area in the parking lot of the Silver Spring Police Department, 5 Willow Mill Park Drive, has been designated as an Internet Purchase Exchange Location. Residents conducting business with strangers through an online buy, sell, barter or trade website may meet at this location for the exchange. The area, designated by a sign, is under 24/7 video surveillance and serves as a deterrent to potential criminal intentions.

Medication and Syringe Disposal Boxes

Residents can deposit expired or unwanted medications or syringes in the special locked disposal boxes located in the police station lobby during the hours of 8 am to 4 pm Monday-Friday, excluding holidays. This free, anonymous service accepts non-liquid prescription and over-the-counter medications in their original containers or in a sealed plastic bag. The permanently secured box is under 24/7 video surveillance. This service helps reduce access to drugs that could lead to accidental or intentional misuse or overdose.

Child Car Seat Installation Inspection

Silver Spring Township Police Department offers inspections of child car seat installations and has an officer who has been trained and certified in child passenger safety seat installation. Citizens first should install the car seat in their vehicle. The officer will inspect it and adjust the installation, if necessary. This free service is by appointment only.

School Resource Officer (SRO)

A Silver Spring Township Police officer is assigned to the Cumberland Valley School District campus during the nine-month school year. The certified SRO spends every day of the school year on campus to help ensure a safe learning environment, provide valuable resources to school staff members and students, foster positive relationships with youth, develop strategies to resolve problems affecting youth, and protect all students, so that they can reach their fullest potential.

EMERGENCY SERVICE PROVIDERS

New Kingstown Fire Company (NKFC)

Chartered in 1911, the New Kingstown Fire Company has grown with the community and continues to operate as a volunteer fire company. NKFC was recognized in 1999, 2000, and 2001 with a Life Safety Achievement Award for no fire deaths due to fire prevention and education programs.

With modern firefighting equipment, NKFC answers over 500 alarms a year in Silver Spring and Middlesex Townships and provides mutual aid to many surrounding townships and boroughs. New Kingstown Fire Company adopted a motto during its early years which is proudly upheld today: "We Strive to Save in Time of Need".

Silver Spring Community Fire Company (SSFCF)

The Silver Spring Community Fire Company was formed in 1954 as an all-volunteer organization providing fire protection and rescue services to the residents of Silver Spring Township and surrounding communities. The SSFCF serves the Township, including suburban and high-density residential

properties, commercial and mid-rise commercial properties, several miles of Interstate 81, non-hydranted semi-rural and rural areas, several schools and a high-population skilled nursing facility. The Silver Spring Community Fire Company responds to an average of 700-800 alarms per year while operating a fleet of state-of-the-art fire apparatus.

Silver Spring Ambulance and Rescue Association (SSARA)

Silver Spring Ambulance and Rescue Association provides emergency medical services within the primary service area of Silver Spring Township and segments of Middlesex Township located in Cumberland County, Pennsylvania. SSARA provides Basic Life Support (BLS) emergency medical services responding to 911 emergency dispatches. Silver Spring Ambulance partners with paramedics from Holy Spirit Emergency Medical Services for Advanced Life Support (ALS) services.

Special Fire Police

The Fire Police of the Silver Spring Community and New Kingstown Fire Companies are volunteers who have received sworn police powers under authority of the Township. Fire Police support fire-fighting and law enforcement efforts on-scene, including scene security and safety, traffic control, crowd control, and road closures. Additionally, Cumberland County maintains a county level Fire Police unit known as the Special Police Emergency Response Team (SPERT) - Team 800. Several members of Township Fire Police are active members with SPERT and many assisted in creating the entity.

COMMUNITY DEVELOPMENT

Please contact the Community Development Department to ensure that your project is reviewed and inspected by qualified personnel for safety and accuracy.

What is the difference between a Building Permit and a Zoning Permit?

A Zoning Permit is required to place a structure on the lot. A Building Permit is required to ensure a structure or repair is built in a safe manner.

Who is responsible for applying for a Permit?

The property owner is responsible for obtaining a building and/or zoning permit. The property owner may appoint an authorized agent to apply for the permit.

When do I need a building permit?

You may need a building permit if you intend to construct, alter, repair, demolish or perform maintenance to a structure, fence or shed. Please contact the Building and Codes Department for assistance.

When do I need a zoning permit?

A zoning permit is generally required when doing anything outside, unless you are not increasing the existing footprint of a structure. For instance, replacing an existing fence or shed in the same spot and at the same size does not require a zoning permit.

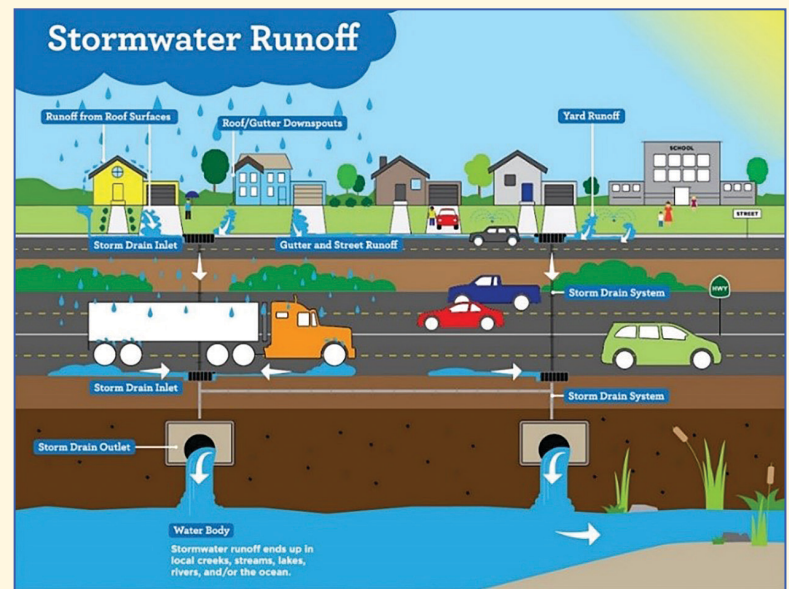
Stormwater Permit

ANY soil disturbance exceeding 1,000 square feet requires a Stormwater permit. Before earthwork begins you must submit a detailed plot plan identifying all new impervious surface coverage and grading plans. Please contact the MS4 Coordinator at 717-766-0178 for additional information concerning stormwater requirements before finalizing plans for your project.

Understanding the MS4 Program

One of the main sources of impairment in our local waterways is untreated stormwater runoff. This runoff is generated from impervious surfaces such as houses, roads, and walkways. During a weather event, water flows rapidly across impervious surfaces, collecting any contaminants, and depositing them into the MS4 (Municipal Separate Storm Sewer System). The MS4 system is comprised of drainage systems such as streets, catch basins, curbs, gutters, channels, pipes, etc. Untreated water will eventually be discharged into the surrounding waterways, where high pollutant loads will cause a negative impact on the water quality.

Due to degraded water quality, the Pennsylvania Department of Environmental Protection (DEP) requires municipalities that meet certain standards to obtain an NPDES permit for the discharge of stormwater. This permit requires that six Minimum Control Measures (MCMs) are met, along with the implementation of the Chesapeake Bay Pollution Reduction Plan (PRP). The PRP consists of a variety of projects that will be implemented throughout the Township to help treat the water that enters the MS4 conveyance system.



Illicit Discharge Reporting

One of the main ways that residents of Silver Spring Township can help keep waterways clean is by reporting illicit discharges. This is the unlawful act of disposing, dumping, spilling, or other discharge of any substance other than stormwater into the stormwater conveyance system (streets, swales, catch basins, inlets, waterways, etc.). Examples include paint, oil/antifreeze, wash water from vehicles, grass clippings, etc. If you suspect an illicit discharge, please contact the MS4 Program Coordinator at 717-766-0178. For large spills please contact DEP at 1-800-541-2050 or call 911.

Burning: Except for campfires and approved bonfires, burning is only allowed in association with agricultural uses on properties of 10 acres or larger.

Grass or weed height: Such vegetation shall not exceed 12 inches in height.

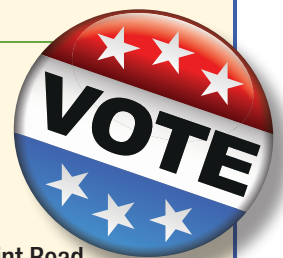

WASTEWATER SYSTEMS

Sanitary Sewer (Public)

The Silver Spring Township Sewer Authority is responsible for operating and maintaining a 1,200,000 gallon per day treatment facility, 25 sewer pumping stations, and over 100 miles of sewer line. A recent treatment facility upgrade has enabled the authority to meet the stringent new waste water nutrient discharge requirements that were adopted by the Department of Environmental Protection through the Chesapeake Bay Initiative. The original treatment facility was constructed in 1990, and approximately 85% of the total sewer collection system has been installed since that time.

If you are unsure if a sewer easement or right-of-way exists on your property, please contact the Authority office at 717-591-1370 for information and details. If your sewer is clogged and you have determined that the blockage is not on your property, please call the Authority and personnel will check the main sewer serving your property. If the problem is in the Authority's main sewer, we will address the problem immediately. If the main sewer serving your home is determined not to be the source of the problem, Authority personnel will contact you to report their findings.

On-Lot Septic (Private)

There are currently 1,864 homes in the Township with septic systems. Township Ordinance provides for the inspection, maintenance and rehabilitation of on-lot sewage systems. This permits the Township to intervene in situations which may constitute a public nuisance or hazard to the public health; and to establish penalties and appeal procedures necessary for the proper administration of a sewage management program. For a well maintained septic system, please remember:

Properly Dispose of Waste: Whether you flush it down the toilet, grind it in the garbage disposal, or pour it down the sink, shower, or bath, everything that goes down your drains ends up in your septic system. What goes down the drain affects how well your septic system works. Toilets aren't trash cans! Your septic system is not a trash can.

Do not flush anything besides human waste, graywater and toilet paper.

Think at the Sink! Your septic system contains a collection of living organisms that digest and treat household waste. Pouring toxins down your drain can kill these organisms and harm your septic system.

- Avoid chemical drain openers for a clogged drain. Instead, use boiling water or a drain snake.
- Never pour cooking oil or grease down the drain.
- Never pour oil-based paints, solvents, or large volumes of toxic cleaners down the drain. Even latex paint waste should be minimized.
- Eliminate or limit the use of a garbage disposal. This will significantly reduce the amount of fats, grease, and solids that enter your septic tank and ultimately clog its drainfield.

Maintain Your Drainfield: Your drainfield is an important part of your septic system. Here are a few things you should do to maintain it:

- **Parking:** Never park or drive on your drainfield.
- **Planting:** Plant trees the appropriate distance from your drainfield to keep roots from growing into your septic system. A septic service professional can advise you of the proper distance, depending on your septic tank and landscape.
- **Placing:** Keep roof drains, sump pumps, and other rainwater drainage systems away from your drainfield area. Excess water slows down or stops the wastewater treatment process.

Practicing these simple steps can help keep your septic system in great shape for years.
